(Roads) contractors of Meghalaya State for under mentioned work and will be received in this office (in Room No.210) on **25th November 2024 upto 3:00 P.M.** The tenders will be opened on the same day at **4:00 P.M.** in presence of the tenderers or their authorized representatives who so desire to witness the opening of the bids.
